In addition, RABAT is dedicated to developing and consolidating strong and lasting relationships with suppliers and other business partners, to promote responsible business practices throughout the supply chain. This commitment includes the adoption of measures aimed at identifying and, where appropriate, mitigating negative social and environmental impacts, paying special attention to issues related

to human rights, child labor and forced labor. To achieve this, RABAT carries out due diligence on all suppliers, always in line with the UN Guiding Principles on Business and Human Rights and the OECD Guide on Due Diligence for Responsible Conflict Minerals Supply Chains. and high risk (OECD Guide).

RABAT has developed internal control systems and processes to collect and record information on the origin of materials supplied and, where available, information related to due diligence carried out by manufacturing partners.

The company is analyzing its supply chain, contacting all partners to communicate and request increasingly in-depth information about business and corporate practices, as well as the origin of the materials used.

The commitment to responsible sourcing extends beyond operations themselves. RABAT has established a robust risk identification system to proactively address potential issues within the supply chain. Additionally, the organization has created an accessible complaints mechanism that allows anyone to raise concerns about unethical or unsustainable practices. This proactive approach ensures that RABAT maintains transparency and accountability, fostering a more ethical and sustainable supply chain ecosystem.

In its ongoing commitment to sustainability and business ethics, the entity has taken a proactive approach to ensure compliance with Responsible Jewellery Council (RJC) standards. RABAT has taken concrete steps by undergoing rigorous third-party audits, conducted by independent experts, to assess compliance with RJC quidelines.

Third-party audits represent an important step in demonstrating dedication to transparency and integrity. These audits are carried out through detailed processes and exhaustive evaluation methodologies to verify that practices fully and consistently comply with RJC standards. The results of these audits provide objective feedback and concrete verification of the commitment to promoting an ethical and sustainable jewelry industry.

RABAT will continue to work with qualified professionals to objectively evaluate its practices and make necessary improvements to maintain the RJC's high standards.
